On behalf of the KFS Team, we're hopeful you, your family and employees are well through this challenging time and although Easter weekend will be different this year due to social distancing, we're optimistic that progress is being made to help limit the duration of the current shutdowns.

As we conclude the 4th week of Covid-19 shutdowns, the various State and Federal orders continue to be very impactful to the food service industry and our valued customers. Recognizing these impacts and the uncertainty regarding duration, we wanted to remind those that haven't already applied for the Cares stimulus (Payroll Protection Program) and also the SBA Disaster Loan Assistance program that these programs are legitimate programs designed to assist small businesses like yours, with loan forgiveness provisions and may prove beneficial for your operation.

Attached is the Payroll Protection Program FAQ document including important links and additional links below for information regarding these available programs. It's important to note that the Cares Stimulus Program is first come first serve and although it's likely the 350 Billion stimulus package for small business will be expanded by an additional 250 billion, the program expansion hasn't yet been approved by congress.

Your commercial lender should be able to assist you either directly or through their on-line portals for the applications and submittal information required.

The Payroll Protection Program application, client data review and SBA submittal, seeking approval through SBA and funding (which includes loan origination documents) is available through your commercial lender. We encourage you to contact them to take advantage of the small business stimulus currently available.
